

#### 1 INTRODUCTION

The Drains Infrastructure Construction Ltd (DICL) is a private company incorporated for the construction of drains in Mauritius and falls under the aegis of the Ministry of National Infrastructure and Community Development.

The DICL has a memorandum of understanding (MoU) with the New Social Living Development Ltd (NSLD), a subsidiary of the National Housing Development Co. Ltd (NHDC), which is a Special Purpose Vehicle mandated to build 12,000 residential units in line with the Government's vision to enhance social housing and build inclusive communities. The MoU concerns the construction of the offsite stormwater drainage network and associated works at the NSLD sites scattered across Mauritius by the DICL for which design has been carried out by DICL Consultants (LuxConsult (Mtius) Ltd and Servansingh Jadav and Partners Consulting Engineers Ltd).

In this regard, the DICL is inviting Expression of Interest from eligible and qualified local and international Contractors for the construction of offsite stormwater drainage network and associated works for the NSLD Sites.

Following expression of interest, the DICL shall subsequently float bidding documents to eligible Contractors for construction of the offsite stormwater drainage network and associated works of the NSLD Sites.

SCOPE OF WORKS

The scope of work shall include inter alia the following:

- 1. Construction of reinforced concrete covered and open drain along and off track/public/RDA road.
- 2. Construction of attenuation basins including major excavation works, provision of chainlink fencing around perimeter of basin, provision of energy dissipators in reinforced concrete and gabion boxes, provision of boulders and vetiver / grass planting amongst others.
